## SEMINAR DATA



Seminar for standardization is a gathering point for stakeholders to talk about HR, safety and privacy in youth work. We will talk about challenges of youth work when it comes to protecting young people safety and privacy and ensuring their rights protection while doing youth work activities. Special focus will be given to HRE of youth organizations (YO), since in dealing with vulnerable groups our work and systems for participants protection should be in special focus. Seminar will result with proposal for methods, materials and procedures for YO to apply standards produced, in the form of Guide for YO.

Objectives of the project are:

- To create learning path for organizations willing to apply data protection standards in their work;
- To exchange view, receive know-how and learn about models of data protection in youth organizations;
- To create draft of guide for youth organizations and prepare for its piloting.
